**INSTRUCTIONS TO CANDIDATES AS TO HOW TO APPLY FOR
THE CDPOs and TWOs (MAIN) WRITTEN EXAMINATION-2014.**

1. The candidates are required to visit at <http://www.hp.gov.in/hppsc> and download the application format.
2. The candidates are advised to fill in the enclosed Application Form and send the same duly filled in along with attested copies of certificates in support of your claim to the Commission on or before 18-10-2014 positively by Registered / Speed post. The application Forms received after the prescribed date i.e. 18-10-2014 and without proof of Essential Qualification, age category etc. shall be rejected.
3. Please note that you will be appearing in this examination under the same Roll No. which was allowed to you in the preliminary/ Screening Test.
4. Please also note that your candidature to this examination is purely provisional subject to the fulfillment of Essential Qualification and prescribed age limit etc. as per the requirement of advertisement No. 2/ 2013 dated 11-10-2013 for the post and the same is liable for rejection if you are found to be ineligible at any stage.
5. The candidates claiming reservation must submit valid certificates of concerned category in support of the claim. In case of invalid certificate, the application will be rejected. The category once claimed shall not be changed.
6. It may be ensured by the candidates before submitting the applications that furnishing of false information and documents of suppression of any factual information in the application form would entail disqualification. If the fact that false information/ document(s) has been furnished or that there has been suppression or any factual information in the application come to the notice at any time during the service of person, the service would be liable to be terminated.
