It is for information of all concerned, who have applied for the post(s) for Range Forest Officer, Class-II(Gazetted) (on contract basis) (in the Department of Forests, H.P.) in response to the Advertisement No. 4/2017 dated 23rd March, 2017 and subsequent Addendum dated 28th July, 2017 that Himachal Pradesh Public Service Commission will hold Screening Test for recruitment to the post(s) of Range Forests Officer only **for Non- B.Sc. (Forestry)** candidates at various centres in Shimla District on 29th October, 2017 from 11:00 A.M. to 01:00 P.M .

The e-Admit cards and instructions to the provisionally admitted candidates for the above mentioned posts have been uploaded on the website of this Commission i.e. **www.hp.gov.in/hppsc** and the candidates have also been informed through SMS/ email on their respective Cellular Nos. and e-mail ID(s) provided by them in their respective Online Recruitment Application forms.

Further due to forthcoming Vidhan Sabha Election in Himachal Pradesh, the Examination Centres allotted to the candidates for above said Screening Test in Govt. Girls Sr. Sec. School Portmore, Shimla (Centre-I & Centre-II) and Govt. Sr. Sec. School Chhota Shimla at Kasumpti, Shimla (Center-I & Centre-II) have been changed/ shifted.
