INSTRUCTIONS TO CANDIDATES FOR SCREENING TEST FOR RECRUITMENT TO THE POSTS OF **ASSISTANT DISTRICT ATTORNEY** IN THE DEPARTMENT OF HOME, H.P. ADVERTISED VIDE ADVERTISEMENT NO.59/11-2021 dated 24-11-2021, subsequent Addendum dated 22-12-2021 and Corrigendum dated 24-02-2022.

Time of Screening Test: **10:00 AM to 01.00 P.M.**

Reporting time :9.00 AM

1. The Candidates are advised to follow SOP/ guidelines issued by the Government of Himachal Pradesh and also issued by the Ministry of Home affairs, Government of India from time to time with regard to Covid-19 pandemic. The SOP is available on the website of the Commission.
2. The candidates are advised to bring their own water, Sanitizer in transparent bottles and wear masks etc. to contain the spread of COVID-19. No candidates will be allowed to enter the Examination Hall/ Rooms (Computer Lab) without mask and thermal screening. The candidates are advised to maintain social distancing and avoid crowding at entry and exit points.
3. You have been admitted provisionally on claim basis to appear in the Screening Test for the post of Assistant District Attorney in the Department of (Home), subject to the fulfillment of eligibility conditions as laid down in Advt. No.59/11-2021 dated 24-11-2021. Your candidature is liable to be cancelled, if you are found ineligible for the post(s) at any stage of the selection process or thereafter.
4. You should bring your e-admission letter and paste latest passport size photograph duly attested by a Gazetted Officer on the e-admit card. No candidate will be allowed to appear in the screening test without photograph.
5. Your eligibility in terms of essential qualification(s) and experience etc. shall be reckoned as on the last date of receipt of online recruitment applications i.e. 31-12.2021
6. The screening test will be of three hours' duration of conventional type questions covering the syllabus of Criminal Law and Civil Law of Degree level.
7. You are advised to reach the examination Centre on the scheduled date at least one hour before the time mentioned in your e-admission letter. No candidate will be allowed to enter the Examination Hall after the commencement of the Test and no candidate will be allowed to leave the examination Hall till the full allotted time is over.
8. Candidates are advised not to bring any valuables / costly items in the examination Hall as safe keeping of the same cannot be assured. Commission will not be responsible for any loss in this regard.
9. Smoking and taking tea is strictly prohibited inside the examination hall / Room.

10. The candidate will furnish such necessary and correct information as may be asked for from him/ her in the examination hall by the Invigilator/ Deputy Superintendent / Centre Supervisor.
11. The candidate must abide by the instructions as may be given by the Centre Supervisor / invigilator of the examination.
12. The candidate must cross the page(s) left blank in his / her Answer Book / Supplementary Answer Book , as the case may be , after attempting the last question during the allotted time of examination.
13. No candidate shall go outside the examination hall / room for any purpose, whatsoever, without prior permission of the Centre Superintendent. No candidate shall go to the toilet during the last 15 minutes of the examination. The candidate should note that he / she should not stand near or loiter in and around the examination Hall after permitted to leave on conclusion of the examination.
14. A candidate is allowed to appear only at the examination Centre allotted to him / her.
15. No. TA/DA will be paid for appearing in the Screening Test.
16. Re-evaluation or rechecking of Answer Book is not permissible nor the Commission enter into correspondence in this examination.
17. Categories claimed by you in your online application as well as shown in your e-admit card will not be allowed to be changed after the conduct of the Examination.
18. NO ELECTRONIC GADGET/ MOBILE PHONE/ ANY OTHER COMMUNICATION/ELECTRONIC DEVICE IS ALLOWED IN THE PREMISES/EXAMINATION HALL, THEREFORE, THE CANDIDATE SHOULD ENSURE THAT THEY ARE NOT IN POSSESSION OF ANY KIND OF SUCH DEVICES BEFORE THEY ENTER THE PREMISES/EXAMINATION HALL,
