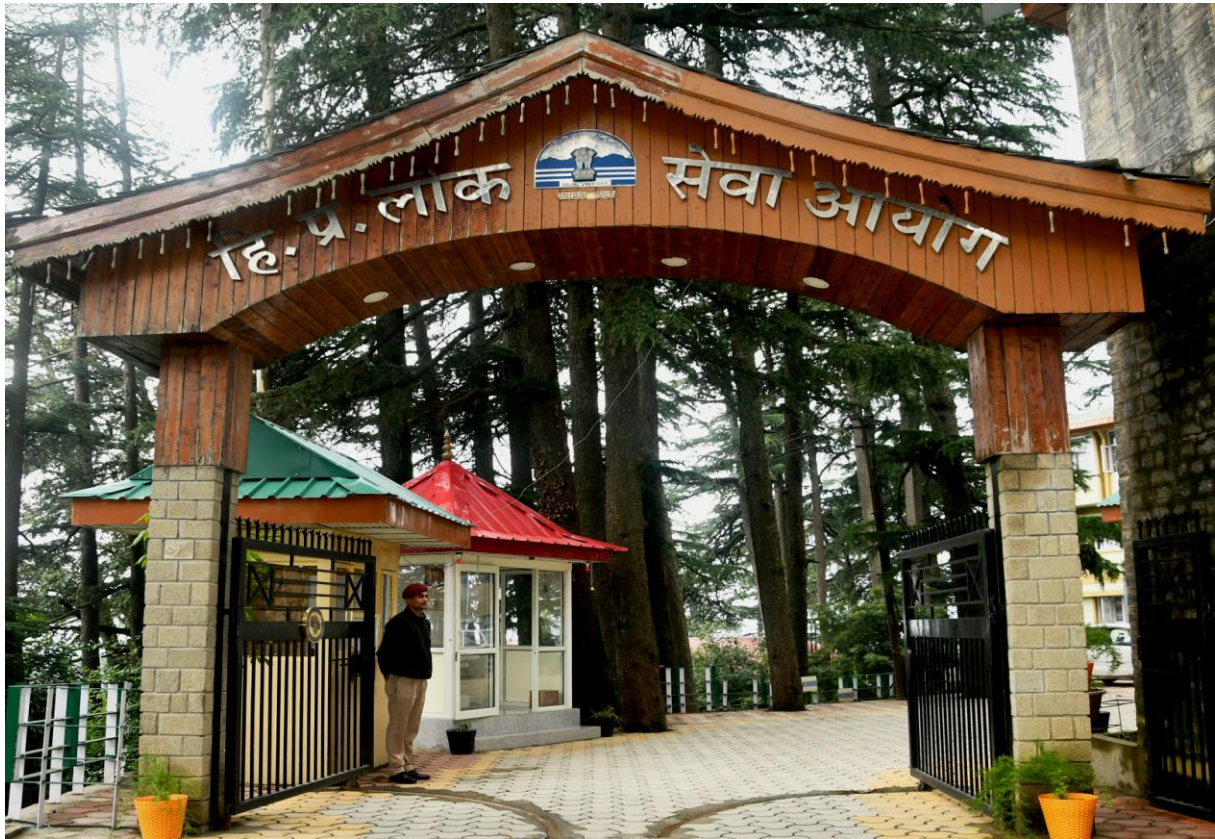

PART-I ORGANISATION

BACKGROUND

I.1 Himachal Pradesh was formed as a union territory on 1st November 1956. Kangra and most of the hill areas of Punjab were merged with Himachal Pradesh on 1st November 1966. Thereafter on 25 January, 1971, Himachal Pradesh was declared as 18th State of India. The state established its own Public Service Commission under article 315 of the constitution on 8th April, 1971.

Under Part XIV chapter-I and in articles 308 to 314 of the constitution of India, the matter related to service under the Union and the states such as recruitment and conditions of service or person serving, dismissal, removal or reduction in rank of persons employed has been provided.

Article 316 deals with the appointment and term of office of the Chairman and Members of PSC.

Article 317 provides the procedure for removal /suspension of Chairman or Members of PSC.

Article 318 gives the power to make regulations as to the conditions of service of Members and staff of the Commission.

Article 319 prohibits the holding of offices under government by the Members of the Commission or ceasing to be such Members.

Article 323 deals with the submission of Annual report by the PSC to the Governor and its being laid before the legislatures. The Commission has so far brought 51 Annual Report since its inception.

BRIEF HISTORY OF THE COMMISSION

I.2 The Himachal Pradesh Public Service Commission (Members) Regulations, 1971 was notified by the Governor of Himachal Pradesh on 8th April, 1971 under Article 318 of the Constitution of India. These Regulations provide that the Himachal Pradesh Public Service Commission shall consist of a Chairman and two Members to be appointed by the Governor. The Himachal Pradesh Public Service Commission (Members) Regulations, 1971 was amended vide notification dated 17.01.1985 and the strength of members was increased from two to three.

Vide notification No. Per (AP.B) A(6)-1/2018 dated 15th January, 2018, the Government of Himachal Pradesh amended the Himachal Pradesh Public Service Commission (Members) Regulations, 1974 and the strength of members was increased from three to five. Since the establishment of the Commission on 8th April, 1971 many distinguished persons have occupied the offices of Chairpersons and Member. The details are mentioned as **Appendix-I** attached.

VISION AND MISSION

I.3 The Himachal Pradesh Public Service Commission pursuant to the provisions laid down in the constitution of India endeavors to support the human resources capability of the Government through absolute transparency, fairness, use of advanced technology platforms and to provide best human resources in all Class-I, Class-II and Class-III posts in a most transparent manners.

HONORS AND AWARDS

I.4 The Himachal Pradesh Public Service Commission has been conferred with E-Governance Award in the Project Category-“State Government 20th SIG e-Governance Awards-2022’ by Computer Society of India for successful implementation of HPPSC-ICT Project.

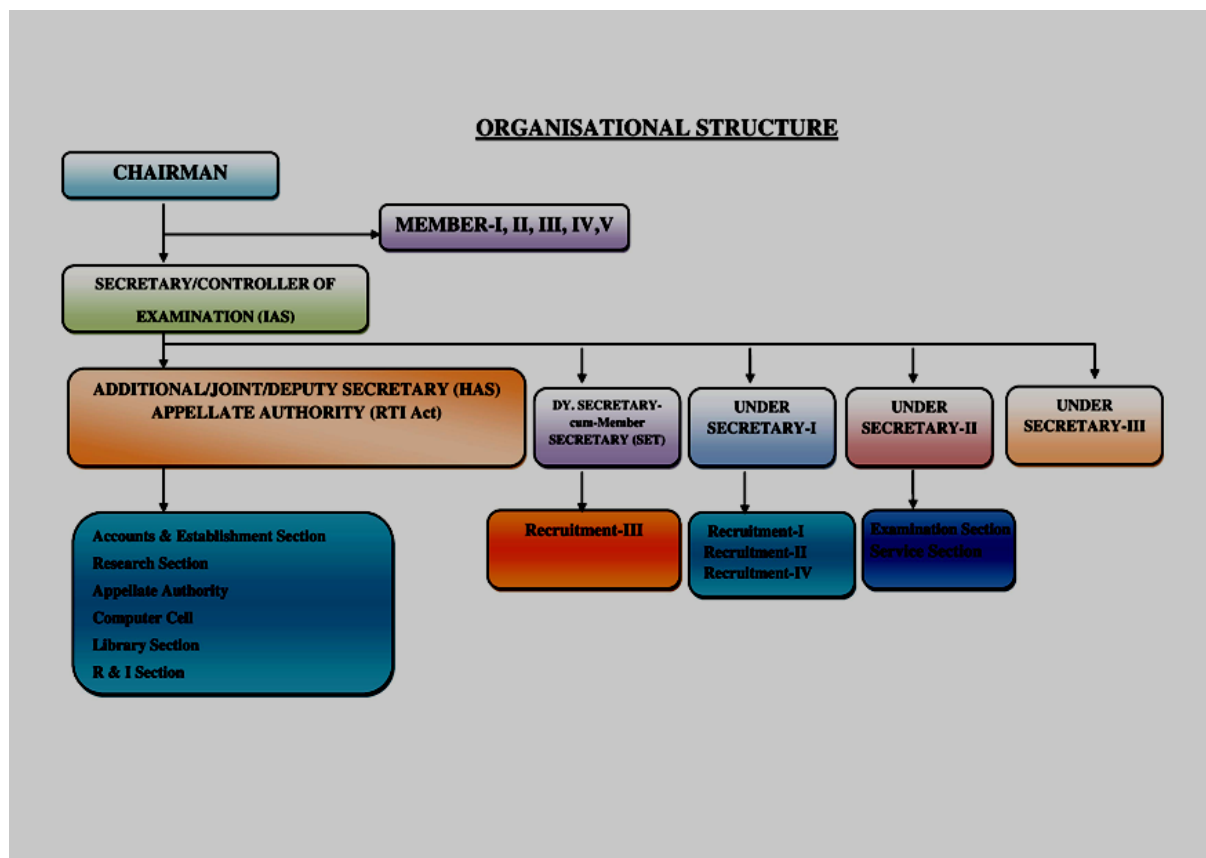

Charter of duties of the Commission

I. 9 The functions and duties of the Union and State Public Service Commission have been defined under Article 320 of the Constitution of India. The Secretary is the Head of the office and therefore controlling officer as per H.P.F.R. The Chairman is the Head of the Department. Duties and functions of supervisory officers and other staff are well defined in the Office Manual which is ipso facto applicable on the employees and supervisory officers of the Commission. However, for the discharge of its functions relating to Recruitment/ Examinations etc, required norms are fixed by the Secretary in consultation with Commission. Such norms etc. are also reflected in the Rules of Business, instructions issued from time to time and different decisions taken by the Commission in this direction

The Rules, Regulations, Instructions, Manuals and Records used for discharging its functions.

The Rules of Business, the H.P.P.S.C. Hand Book, decisions of the Commission, instructions issued from time to time by the Commission and the Govt. are used for discharging different duties by the employees/ officers of the Commission. For dealing with establishment, Budget/ Travelling Allowance/ L.T.C./ G.P.F./ M.R. claims, store & Stationery, following Rules / Manuals etc. are also followed :—

H.P.F.R., Budget Manuals, T.A. Rules, L.T.C. Rules, Medical Attendance Rules, CCS (GPF Rules), CCS (CCA) Rules, 1965, CCS (Conduct) Rules 1964, CCS (Temp.) Rules, CCS (Leave) Rules, 1972, CCS (Pension) Rules, Office Manual.

Branches/Sections

The Commission consists of nine branches/Sections:

- (a) Accounts and Establishment Section.
- (b) Recruitment-I Section
- (c) Recruitment-II Section
- (d) Recruitment-III Section
- (e) Recruitment-IV Section
- (f) Service Section
- (g) Examination Section
- (h) Research Cell
- (i) Computer Cell.

DECISION MAKING PROCEDURE:-

Entire work of the Commission is dealt as per the Rules of Business. Generally there are three levels at which decisions on different matters are taken i.e. Secretary, the Chairman and the Commission.

The proposals or any references/ representations etc. received from different quarters are put up by concerned Assistants and submitted to the Section Officer which is the first channel of supervision. After examination at the level of section officer, the matter is submitted to the Branch Officer *i.e.* Under Secretary and Deputy Secretary who submits all matters through Deputy Secretary/ Joint Secretary/Additional Secretary/Special Secretary as the case may be. The Deputy Secretary/ Joint Secretary/Additional Secretary/Special Secretary submit the case to the Secretary. If the Secretary is empowered to dispose of the matter then he disposes off the case and if he is not empowered then the case is put up to the Chairman/ Commission as per Rules of Business.

Applications received from candidates for different posts are admitted at the office/ Secretary level as per rules and conditions put in the advertisement. Only those applications are put up to the Commission for orders where specific need for such orders is felt by the Secretary. The Chairman may direct any matter to be placed before the Commission if need so felt. Any advice on service matter sought by the Government is placed before the Commission and communicated accordingly. The interviews are taken by the Chairman himself or any other Member or Members as assigned by him. The meeting of D.P.C. is presided over by the Chairman or Member nominated by him.

ADDITIONAL FUNCTIONS

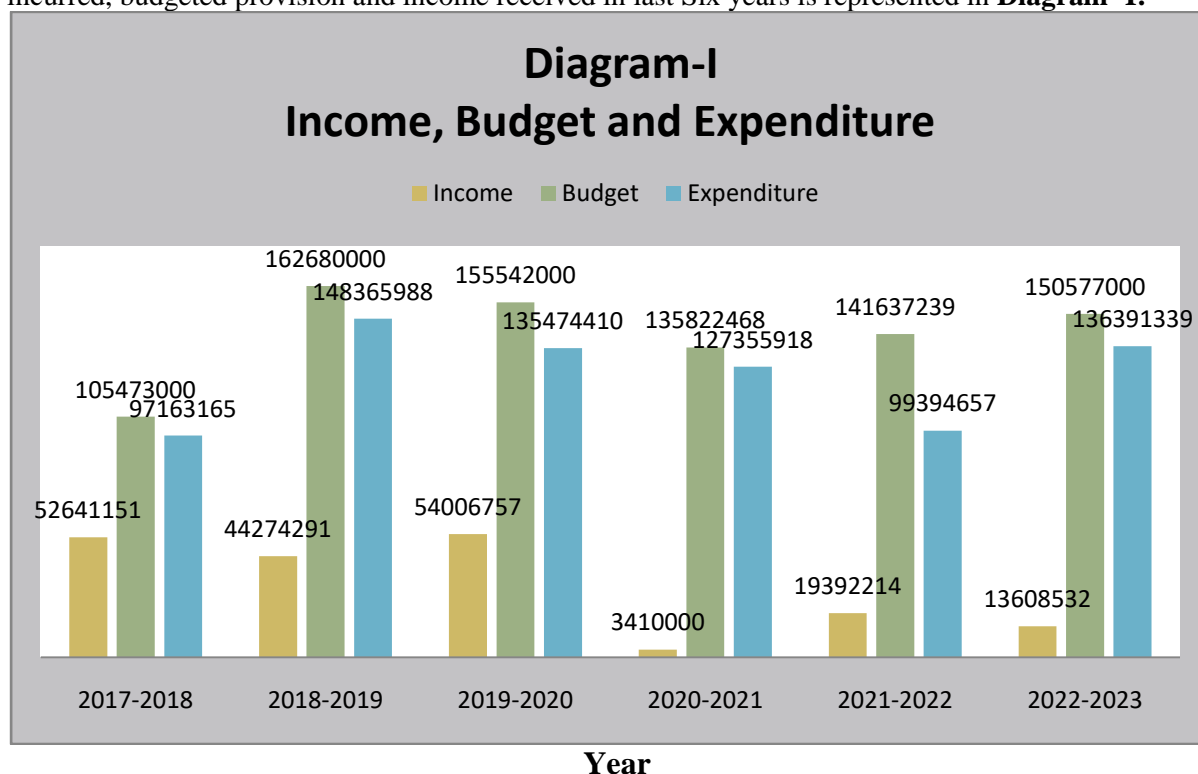
I.10 The Himachal Pradesh Public Service Commission was set up under Article 315 of the Constitution of India to discharge the duties and functions, assigned to it under Article 320 of the Constitution. The underlying idea was to have within the State an independent and impartial Constitutional Authority which may give advice and recommendations on all matters referred to it. By virtue of the provisions made in the Constitution, the Commission is required to conduct examinations for appointments to the services of the state as decided by Government and to advise the State Government on all matters relating to framing of Recruitment and Promotion Rules, principles to be followed in making appointments, promotions and transfers from one service to another and in respect of disciplinary matters for Civil Servants under the state of Himachal Pradesh.

The Himachal Pradesh Public Service Commission (**ADDITIONAL FUNCTIONS**) Act, 2018 (as assented by the Governor on 10th October, 2018) was notified by the Government of Himachal Pradesh on 17th October, 2018 to entrust the additional functions to the Himachal Pradesh Public Service Commission with regard to making recommendations for recruitment of persons and advise regarding the service matters of various institutions viz. Boards and Corporations.

The Commission also assists the Union Public Service Commission in the conduct of various examinations within the State of Himachal Pradesh

RECEIPTS, EXPENDITURE AND BUDGET

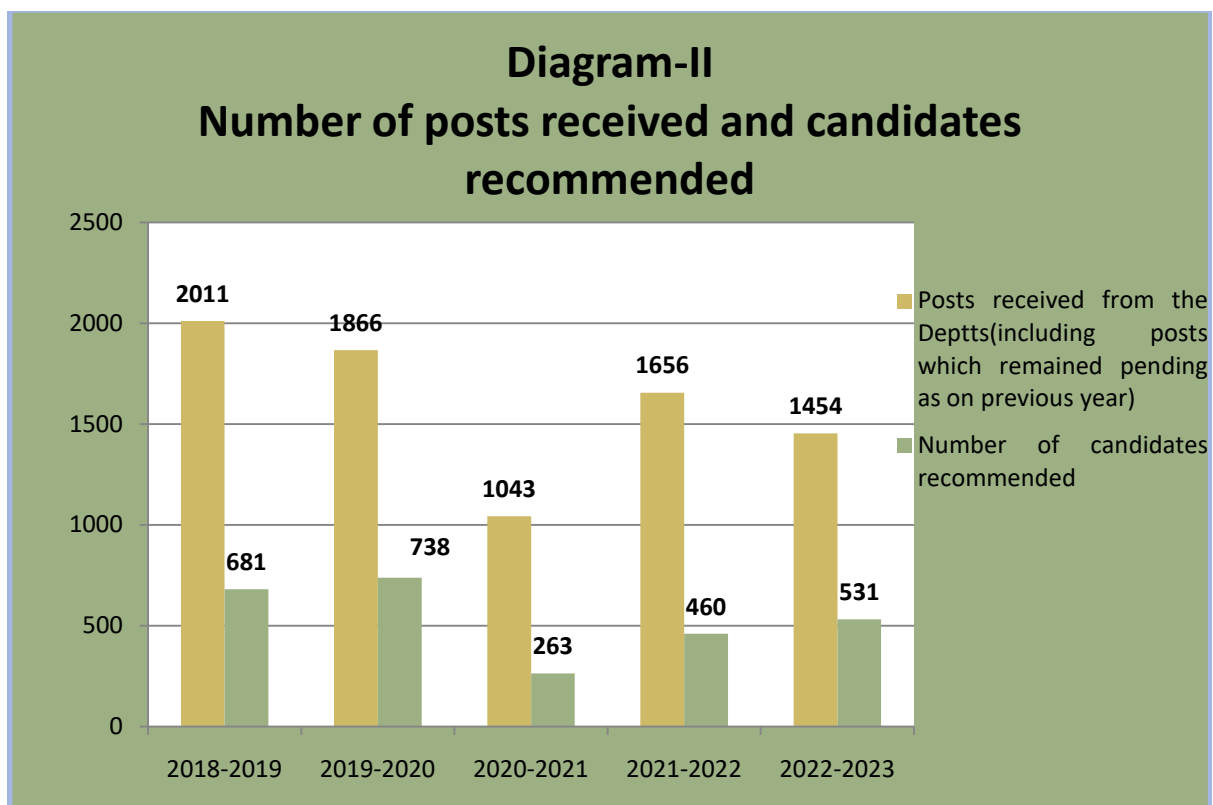
I.11 The Commission incurred an expenditure of ₹ 13,63,91,339 against a total budgetary provision of ₹ 15,05,77,000 under various heads and had receipt of ₹ 1,36,08,532 during the year. III. 1 The Commission received requisitions for 1454 posts (Gen-643, S.C.-155, S.T.-77, O.B.C.-130, Gen Ex.SM -177, Gen. Ward of Ex.SM-60, SC Ex. SM-22, SC Ward of Ex.SM-08, ST Ex. SM-07, ST Ward of Ex.SM-02, OBC Ex. SM-13, OBC Ward of Ex.SM-03, Gen. WFF-05, SC WFF-04, OBC WFF-02, P.H.-42, Gen. EWS-104) against which 531 candidates (Gen-312, S.C.-68, S.T.-32, O.B.C.-52, Gen. Ex SM-10, SC Ex. SM -01, Gen. WFF-02, EWS-49, PH-05) were recommended. (Appendix-VIII, IX, X & XI refers)

In the discharge of its Constitutional obligations, the Commission continued to advise the State Government in matters pertaining to Recruitment & Promotion Rules, ad-hoc appointments, promotion matters, disciplinary cases and on various other matters referred to it for its advice.

III. 2 The Commission received 10 proposals of draft Recruitment and Promotion Rules for various posts/ services from various departments of the Government. The Commission accorded its approval in 08 cases and 02 cases were pending during the year under report. (**Appendix-XII & Appendix-XIII refers**)

DRAFT AMENDMENT TO RECRUITMENT AND PROMOTION RULES

III. 3 The Commission received 42 cases of draft amendments to the notified Recruitment and Promotion Rules, out of which 35 cases were approved, 07 cases remained pending for want of complete information/ documents from the concerned department. (**Appendix-XIV & XV refers**)

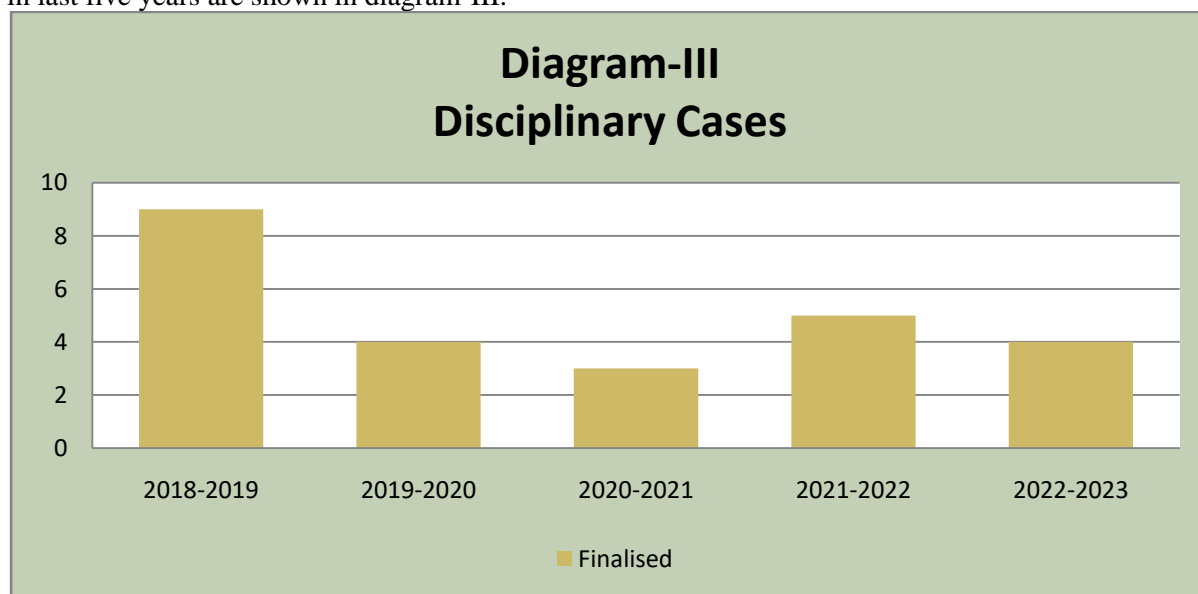
III. 4 The Commission received 15 cases for relaxation of provision of Recruitment & Promotion Rules. The Commission accorded its approval in 10 cases and 05 cases were not approved. (**Appendix-XVI refers**)

III. 5 During the year, the Commission finalized 91 cases of Departmental Promotion in respect of various departments involving **1109 officers (Gen-984, SC-101, ST-24)**. III.6 During the period under report, the Commission received 05 cases pertaining to disciplinary proceedings against officers for advice. 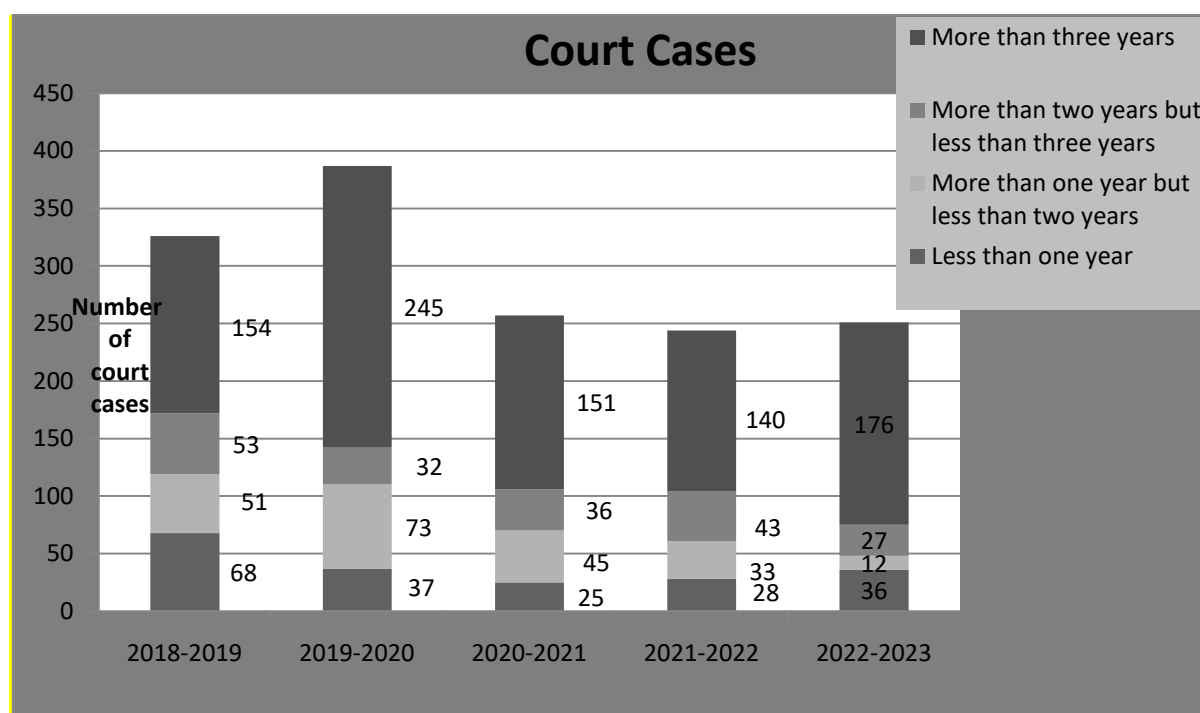
NON-ACCEPTANCE OF COMMISSION'S ADVICE/NON CONSULTATION WITH THE COMMISSION

III.7 The Commission is under a Constitutional obligation to give its advice to Government in all cases referred to it under Article 320 (3) of the Constitution of India. COURT CASES

IV.1 During the period under report 36 cases were decided by different Courts and 251 cases are pending in the court. Out of these 36 cases were of less than one year, 12 more than a year but less than two years and 27 more than two years but less than three years whereas 176 cases were pending for more than three years.

PART-V APPOINTMENTS & MEETINGS

AD-HOC APPOINTMENTS

V. 1. (i) It has come to the notice of the Commission that some of the departments have resorted to making ad-hoc appointments to various posts and promoting officers without consulting the Commission by taking alibi to the provision of Regulation No.5 of the H.P. Public Service Commission (Exemption from Consultation) Regulations, 1973. These departments have not adhered to the instructions of the Government issued from time to time and the instructions contained in para-14 at page 35 of the H.P.P.S.C. Hand Book supplied to all the Administrative Departments. The relevant portion of these instructions is as under:—

“an ad-hoc appointment may be made in a permanent post (for a period not exceeding six months) without consulting the Commission only if, owing to an emergency having arisen, it is necessary in the Public interest to fill up the vacancy immediately and there is likely to be undue delay in making the appointment after consultation with the Commission. Where these conditions are not satisfied, consultation with the Commission is obligatory before making an ad-hoc appointment in a permanent post. This however, does not apply to ad-hoc appointment in a temporary post for a period not exceeding six months”

V-1 (ii) Despite repeated requests made by the Commission and instructions issued by the Government for submission of half-yearly returns of the ad-hoc appointments, no return has been received from any department.

V-1 (iii) During the year under report, the Government sought approval of the Commission for extension of continued ad-hoc appointments beyond six months, as also for ad-hoc appointments in the absence of Rules at the initial stage to various posts/services in one case and the same is not approved. (**Appendix-XX**)

COMMISSION'S MEETINGS

V.2 The Commission carries out weekly meeting on every Tuesday in which routine matters to include results, requisitions, R&P rules etc are discussed and decided.

In addition matters regarding urgent hearing/expending decision are also taken up on priority by circulating amongst Members and if required emergent meeting there to is held.
