- 1. With reference to your application for the post of Assistant Town Planner, Class-I (Gazetted) (on contract basis) in the Department of Town & Country Planning, H.P. advertised vide Advertisement No.62/12-2022 dated 27-12-2022 and after security of documents, you have been provisionally admitted to the said post and now the Personality Test for this post will be held w.e.f 22-01-2024 &23-01-2024 in the office of the Himachal Pradesh Public Service Commission, Nigam Vihar Shimla-171002.
- 2. That you should ensure your presence in the H.P. Public Service Commission on the day of Personality Test (date indicate in e-admit card) at 08:30 A.M. i.e. on the day of Personality Test for verification of documents before appearing in the Personality Test Board.
- 3. The fact that you have been invited for Personality Test does not confer any right on you for selection against the post.
- 4. Please bring original Degree and Result-cum- Detailed Marks Certificates/ Sheet along with attested copies of the following documents with you:-
 - (i) Matriculation certificate showing your date of birth.

(a) Essential Qualification:-

(i) Master of Planning/ M.Tech/ Post Graduate Degree in Urban Planning or City Planning or Town Planning or Regional Planning or Housing Planning or Country Planning or Rural Planning or Infrastructure Planning or Transport Planning or Rural & Urban Planning or Environmental Planning from a recognized University or an Institute duly recognized by the All India Institute of Town Planners, India.

Or

(ii)Bachelor of Planning or Bachelor of Technology in Planning from a recognized University or an Institute duly recognized by the All India Institute of Town Planner, India:

And

Minimum three years experience in Urban Planning or City Planning or Town Planning or Regional Planning or Housing Planning or Country Planning or Rural Planning or Infrastructure Planning or Transport Planning or Rural & Urban Planning or Environmental Planning in the Central Government / State Government Department(s) or private sector after acquiring the qualification of Bachelor of Planning or B. Tech. Degree in Planning but after acquiring the prescribed experience in the public/ private sector, the candidate should produce the following documents at the time of interview/ personality test:-

- (i) Copy of placement letter.
- (ii) Salary Slip
- (iii) ITRs
- (iv) Experience in Planning field to be validated/ certified by a competent authority in Town & Country Planning Department in case of Private Sector.

Knowledge of customs manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

- 5. Scheduled Caste / Scheduled Tribe or latest (valid) Other Backward Class certificate / EWS certificate on the prescribed form, if you belong to any of these categories. The S.C. / S.T /
 - O.B.C. certificate should be based on **parentage basis.** The candidates belonging to Exservicemen category shall bring discharge certificate & other related document issued by the competent authority as a proof of being Ex-serviceman.

- 6. <u>"No Objection Certificate"</u> from your present employer in case working on regular basis in Government /Semi Government Organization. <u>Without N.O.C.</u> you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce N.O.C.
- 7. A latest <u>Character certificate</u> from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and <u>other Character certificate</u> from Head of the Institution last attended.
- 8. You should download <u>Attestation Form</u> through the link provided in the Personality Test Call Letter and bring it with you duly filled in all respect and also <u>bring two (extra) passport size recent photographs duly attested by the same authority who attests your Attestation <u>Form</u> on the day of Personality Test.</u>
- 9. Any other certificates of your academic qualifications etc. in support of your eligibility for the post as required as per Commission's **Advertisement No.62/12-2022 dated <u>27-12-2022</u>**.
- 10. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications (ORAs) i.e. 23-01-2023.
- 11. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date).
- 12. Your admission to the Personality Test is purely provisional subject to the verification of your eligibility as per rules / instructions.
- 13. Onus of proving that you are eligible for the post is on you only. If the date of notification / declaration of result is not indicated in the certificate / degree / marks list, the date of issue of certificate / degree / marks list shall be deemed as date of acquiring essential qualification.
- 14. If you fail to produce any of the certificates mentioned above, which is necessary to determine your eligibility and/or you are found ineligible vis-à-vis qualifications, you will not be allowed to appear before the Personality Test Board and no further time will be allowed to produce any document.

A. / D.A. will be paid for appearing in this Personality Test However, 30% discount is allowed by the H.R.T.C. in ordinary buses only for attending the Personality Test as per communication received from HRTC and discount will be applicable for only three days i.e. one day before and after the Personality Test for to & fro journey.
