Instructions to Candidates for Personality Test for recruitment to the post of Environment Officer, Class-I (Gazetted) (Trainee) in the Department of Environment, Science, Technology & Climate Change H.P.

1. With reference to your application for the post of Environment Officer, Class-I (Trainee) in the Department of Environment, Science, Technology & Climate Change H.P. advertised vide Advertisement No. 26/12-2024 dated 04-12-2024, and the Screening Test/Subject Aptitude Test for the said post(s) was conducted on 05.06.2025. Based on the performance in the Screening test /Subject Aptitude Test, you have been provisionally admitted for the Personality Test for the said post will be held on 17.11.2025 to 19.11.2025 in the office of the Himachal Pradesh Public Service Commission, Nigam Vihar Shimla-171002.
2. That you should ensure your presence in the H.P. Public Service Commission on the day of Personality Test (date and time indicate in e-call letter) at 08:00 A.M. i.e. on the day of Personality Test.
3. The fact that you have been invited for Personality Test does not confer any right on you for selection against the post.
4. Please bring all original documents including Degree and Result-cum-Detailed Marks Certificates/Sheet along with attested copies of the following documents with you:-

The Essential Qualifications:

- i. Matriculation Certificate or other equivalent certificate showing your date of birth.
 - ii. M.Sc. in Environmental Science / Chemistry / Botany or M.Tech. in Environment / Civil Engineering from a recognized University or from an Institute duly recognized by the Central / Himachal Pradesh Government..
 - iii. At least 05 years (Post M.Sc./M.Tech./M.E.) work experience in Environment related project/ programmes formulation and Implementation or preparation of feasibility reports of Environment management projects, analysis and monitoring and conducting survey studies of Environment related projects / programme or Research and Development in Environmental climate change sector or working on protection and conservation of Natural resources, Bio resources from a Government/Semi Government Institutions/ Organizations or an Institution duly recognized by the State/Central Government.
5. Scheduled Caste/Scheduled Tribe and **latest (valid) Other Backward Class /EWS certificate** on prescribed form, if you belong to any of these categories. The S.C./S.T /O.B.C.

certificate should be based on **parental basis**. The candidates belonging to Ex- Servicemen category shall bring discharge certificate & other related document issued by the competent authority as a proof of being Ex-serviceman.

6. **“No Objection Certificate”** from your present employer in case working on regular basis in Government /Semi Government Organization. Without N.O.C. you will not be allowed to appear before the Personality Test Board and no further time will be allowed to produce N.O.C.
7. A latest **Character certificate** from a responsible Officer (Gazetted Officer of Government /Semi Government Organization) and **other Character certificate** from Head of the office/Institution or any other Gazetted Officer.
8. You should download **Attestation Form** through the link provided in the Personality Test Call Letter and bring it with you duly filled in all respect and also **bring two (extra) passport size recent photographs duly attested by the same authority who attests your Attestation Form** on the day of Personality Test.
9. Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission’s advertised vide Advertisement No. **26/12-2024 dated 04.12.2024**.
10. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 05.02.2025.
11. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date).
12. Your admission to the Personality Test is purely provisional subject to the verification of your eligibility as per rules / instructions.
13. Onus of proving that you are eligible for the post is on you only. If the date of notification / declaration of result is not indicated in the certificate / degree / marks list, the date of issue of certificate / degree / marks list shall be deemed as date of acquiring essential qualification.
14. If you fail to produce any of the certificates mentioned above, which is necessary to determine your eligibility and/or you are found ineligible vis-à-vis qualifications, you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce any document.
15. Besides, your eligibility will be subject to the conditions given in Advertisement No.26/12-2024 dated 04.12.2024.
16. No T. A. / D.A. will be paid for appearing in this Personality Test However, 30 % discount is allowed by the HRTC in ordinary buses only for attending the Personality Test as per communication received from HRTC and discount will be applicable for only three days i.e. one

day before and after the Personality Test for to & fro journey.

(ii) NO ELECTRONIC GADGET / MOBILE PHONE / PENDRIVE / BLUETOOTH ANY OTHER COMMUNICATION / ELECTRONIC DEVICE IS ALLOWED DURING THE PERSONALITY TEST. THEREFORE, THE CANDIDATE SHOULD ENSURE THAT THEY ARE NOT IN POSSESSION OF ANY KIND OF SUCH DEVICES BEFORE THEY ENTER THE PREMISES.
