Instructions to Candidates for Personality Test for the post(s) of Lecturer, Applied Sciences & Humanities, Chemistry, Class-I (Gazetted) (on Contract basis) in the Department of Technical Education, Vocational & Industrial Training, H.P.

- Note:- Candidates are advised to follow SOPs / guidelines issued by the Government of Himachal Pradesh (in the Department of Revenue-Disaster Management Cell) and guidelines issued by the Ministry of Health & Family Welfare, Government of India from time to time with regard to COVID-19 pandemic.
- That you have been declared qualified in the Objective Type Computer Based Screening Test held on 25-03-2021 for the post(s) of Lecturer, Applied Sciences & Humanities, Chemistry, Class-I (Gazetted) (on Contract basis) in the Department of Technical Education, Vocational & Industrial Training, H.P., advertised vide Advertisement No.4/2020 Dated 07-03-2020 Item No.II(c) & Public Notice dated 21-05-2020 and now the Personality Test for the said post will be held on 23-08-2021 in the office of the Himachal Pradesh Public Service Commission, Nigam Vihar Shimla-171002.
- 2. That you should ensure your presence in the H.P. Public Service Commission on the day of Personality Test for verification of documents before appearing in the Personality Test.
- 3. The fact that you have been invited for Personality Test does not confer any right on you for selection against the post.
- 4. Please bring original Degree and Result-cum- Detailed Marks Certificates/ Sheet along with attested copies of the following documents with you:
 - i) **<u>Matriculation certificate</u>** or other equivalent certificate showing your <u>date of birth</u>.
 - ii) The Essential Qualifications:

1st Class Master's Degree in appropriate subject viz: Physics, Chemistry, Mathematics or English from a recognized University.

- 5. Scheduled Caste / Scheduled Tribe and latest (valid) Other Backward Class certificate on the prescribed form, if you belong to any of these categories. The S.C. / S.T / OBC certificate should be based on **parental basis**. The candidates belonging to OBC of HP category are required to produce valid / latest OBC certificate which should not be more than 01 years old at the time of Personality Test alongwith an affidavit duly attested by the authority authorized under the Indian Oath Act stating that his / her status has not been changed and he / she is not excluded from category of OBC on account of being covered under creamy layer. <u>The candidates belonging to Ex-Servicemen category shall bring discharge certificate & other related document issued by the competent authority as a proof of being <u>Ex-serviceman</u>. <u>Similarly, candidate belonging to PWD (Person With Disability) of H.P. (having not less than 40% disability) should also bring proof / latest certificate issued by the competent authority.</u></u>
- 6. "No Objection Certificate" from your present employer in case working on regular basis in Government /Semi Government Organization. Without N.O.C. you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce N.O.C.
- 7. Latest Character certificate from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and <u>other Character certificate from Head of the Institution last attended.</u>
- 8. You should also bring with you enclosed <u>Attestation Form</u> duly filled in all respect and <u>bring two (extra) passport size recent photographs duly attested by the same authority</u> <u>who attests your Attestation Form</u>.
- 9. Ward of Ex-Serviceman Certificate issued by a competent authority along with a latest affidavit duly attested by the authority authorized under the Indian Oath Act to the effect that no person in the family has been rehabilitated through employment against the posts reserved for Ex-Servicemen under the Government of Himachal Pradesh.
- 10. Certificate of Bonafide of Himachali.

- Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission's advertised vide Advertisement No.4/2020 dated 07-03-2020 [Item No. II(c)] & Public Notice dated 21-05-2020.
- 12. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 01-06-2020. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date).
- 13. Your admission to the Personality Test is purely provisional subject to the verification of your eligibility as per rules / instructions.
- 14. Onus of proving that you are eligible for the post is on you only. If the date of notification / declaration of result is not indicated in the certificate / degree / marks list, the date of issue of certificate / degree / marks list shall be deemed as date of acquiring essential qualification.
- 15. If you fail to produce any of the certificates mentioned above, which is necessary to determine your eligibility and/or you are found ineligible vis-à-vis qualifications, you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce any document.
- 16. Besides, your eligibility will be subject to the conditions given in Advertisement No.4/2020 dated 07-03-2020 {Item No. II(c)} & Public Notice dated 21-05-2020.
- 17. No T. A. / D.A. will be paid for appearing in this Personality Test However, 30 % discount is allowed by the HRTC in ordinary buses only for attending the Personality Test as per communication received from HRTC and discount will be applicable for only three days i.e. one day before and after the Personality Test for to & fro journey.
