- 2. That you should ensure your presence in the H.P. Public Service Commission on the day of Personality Test (date indicated in e-admit card) at 08:30 A.M. i.e. on the day of Personality Test for verification of documents before appearing in the Personality Test Board.
- 3. The fact that you have been invited for Personality Test does not confer any right on you for selection against the post.
- 4. Please bring original Degree and Result-cum- Detailed Marks Certificates/ Sheet along with attested copies of the following documents with you:-
 - (i) Matriculation certificate showing your date of birth.

Essential Qualification: Certificates as per Advertisement.

- i) Post Graduate Degree in Agriculture/Zoology/Botany/Horticulture/Forestry/Biotechnology/Sericulture from Govt. recognized university or aninstitution duly recognized by the H.P./Central Govt.
- ii) Post qualification three months training in the branch of Sericulture from a Government recognized Institution or Government registered private Institution/organization.

OR

- i)First Class Bachelor's Degree with the subject of Agriculture / Zoology/ Botany/ Horticulture/ Forestry/ Biotechnology / Sericulture from a recognized university or an institution duly recognized by the H.P./Central Govt.
- ii) Post qualification three months training in the branch of Sericulture from a Government recognized Institution or Government registered privateInstitution/organization.
- iii) Post qualification one year work experience in Sericulture & Silk Industry inGovernment organization or Government registered privateorganization.

Desirable Qualification

- 1. Knowledge of customs, manners dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the state.
- 5. Scheduled Caste / Scheduled Tribe or latest (valid) Other Backward Class certificate / EWS certificate on the prescribed form, if you belong to any of these categories otherwise your candidature will be cancelled. The S.C. / S.T / O.B.C. certificate should be based on parentage basis. The candidates belonging to Ex- servicemen category shall bring discharge certificate & other related document issued by the competent authority as a proof of being Ex-serviceman. No further time will be allowed to produce these certificate(s).
- 6. <u>"No Objection Certificate"</u> from your present employer in case working on regular basis in Government /Semi Government Organization. <u>Without N.O.C.</u> you will not be allowed to appear before the Personality Test board and **no further time will be allowed to produce N.O.C.**
- 7. A latest <u>Character certificate</u> from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and <u>other Character certificate</u> from Head of the Institution last attended.

- 8. You should download <u>Attestation Form</u> through the link provided in the Personality Test Call Letter and bring it with you duly filled in all respect and also <u>bring two (extra) passport size</u> <u>recent photographs duly attested by the same authority who attests your Attestation Form on the day of Personality Test.</u>
- 9. Any other certificates of your academic qualifications etc. in support of your eligibility for the post as required as per Commission's **Advertisement No.35/05-2022 dated <u>06-05-2022</u>**.
- 10. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications (ORAs) i.e. **28-06-2022.** In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date).
- 11. Your admission to the Personality Test is purely provisional subject to the verification of your eligibility as per rules / instructions.
- 12. Onus of proving that you are eligible for the post is on you only. If the date of notification / declaration of result is not indicated in the certificate / degree / marks list, the date of issue of certificate / degree / marks list shall be deemed as date of acquiring essential qualification.
