Attested or Self attested copies of following documents are required to be submitted by the above mentioned candidates:-

- (i) A Print out of online recruitment application form (ORA).
- (ii) Matriculation certificate or other equivalent certificate showing your date of birth.
- (iii) **Essential qualification(s):**  
Bachelor's degree in any discipline from an Institution/ University recognized by the Govt.-copy of degree or Detailed Marks Certificates (DMCs).
- (iv) Scheduled Caste/ Scheduled Tribe/ EWS/ latest Other Backward Classes certificates on the prescribed performa(s), if you belong to any of these categories **and Bonafide Himachali Certificate for candidates belonging to reserved categories**. The S.C/ S.T/ OBC certificate should be based on parental basis.
