- (iv) Scheduled Caste/ Scheduled Tribe/ EWS/ latest Other Backward Classes certificates on the prescribed performa, if you belong to any of these categories **and Bonafide Himachali Certificate for candidates belonging to reserved categories**. The S.C/ S.T/ OBC certificate should be based on parental basis.
- (v) Candidates applying under EWSs category will have to submit either 'Income & Asset Certificate' or valid BPL Certificate countersigned by B.D.O. alongwith 'Non-SC/ST/OBC Certificate' issued by the competent authority on the format prescribed by GoHP vide letter No. PER (AP)-C-B(12)-1/2019 dated 11th June, 2019.
- (vi) Persons with disabilities of H.P. (Low vision) (having not less than 40% disability), will have to submit Disability Certificate thereof.
