- (ii) Three years post M.Sc. experience in research training and analytical work in one of the above subjects from any recognized Lab./ Institute / University. (Research work done in the above subjects/fields for doing Ph.D Degree shall be counted in total experience).

(b) Desirable Qualification:-

Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

- 5. Scheduled Caste / Scheduled Tribe or latest (valid) Other Backward Class certificate / EWS certificate on the prescribed form, if you belong to any of these categories. The S.C. / S.T
 - O.B.C. certificate should be based on **parentage basis.** The candidates belonging to Exservicemen category shall bring discharge certificate & other related document issued by the competent authority as a proof of being Ex-serviceman.
- **6** <u>"No Objection Certificate"</u> from your present employer in case working on regular basis in Government /Semi Government Organization. <u>Without N.O.C.</u> you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce N.O.C.
- 7 A latest <u>Character certificate</u> from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and <u>other Character certificate</u> from Head of the Institution last attended.
- You should download <u>Attestation Form</u> through the link provided in the Personality Test Call Letter and bring it with you duly filled in all respect and also <u>bring two (extra) passport size</u> <u>recent photographs duly attested by the same authority who attests your Attestation Form</u> on the day of Personality Test.
- 9 Any other certificates of your academic qualifications etc. in support of your eligibility for the post as required as per Commission"s **Advertisement No.52/07-2022 dated 09-07-2022.**

- 10 Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications (ORAs) i.e. 05-08-2022.
- 11 In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date).
