 - (ii) (a) Essential Qualifications:-

Associate Member of the Institute of Chartered Accountants of India / Associate Member of the Institute of cost & works- Accountants of India with 2 years experience in Finance & Accounts in a Financial Institution/ Commercial Bank / Commercial Organization / PSU or Private practice.

- 5. Scheduled Caste / Scheduled Tribe or latest (valid) Other Backward Class certificate on the prescribed form, if you belong to any of these categories. The S.C. / S.T / O.B.C. certificate should be based on **parental basis**.
- 6. "No Objection Certificate" from your present employer in case working on regular basis in Government /Semi Government Organization. Without N.O.C. you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce N.O.C.
- 7. Latest <u>Character certificate</u> from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and <u>other Character certificate</u> from Head of the Institution last attended.
- 8. You should downloaded <u>Attestation Form</u> through the link provided in the Personality Test Call Letter and bring it with you duly filled in all respect and also <u>bring two (extra) passport size</u> <u>recent photographs duly attested by the same authority who attests your Attestation Form</u> on the day of Personality Test.
- 9. Any other certificates of your academic qualifications etc. in support of your eligibility for the post as required as per Commission's Advertisement No.10/2019 dated 27.07.2019 (Item No. I)

- 10. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 16.08.2019. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date).
