 - <u>Matriculation certificate</u> or other equivalent certificate showing your <u>date of birth</u>.
 - The Essential Qualifications:
 - A recognized medical qualification included in the first or second schedule or part-II of the third schedule (other than licentiate qualifications) to the Indian Medical Council Act-1956. Holders of educational qualification(s) included in part-II of the third schedule should also fulfill the conditions stipulated in sub-section (3) of section-13 of the Indian Medical Council Act, 1956.
 - A postgraduate degree in the concerned speciality as mentioned in Part-A of Annexure-II or its equivalent qualifications.

- At least 3 years teaching experience as Lecturer / Registrar / Demonstrator/ Resident after doing post-graduation in the concerned speciality in any recognized Medical College.
- 5. "No Objection Certificate" from your present employer in case working on regular basis in Government /Semi Government Organization. Without N.O.C. you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce N.O.C
- 6. Latest Character certificate from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and other Character certificate from Head of the Institution last attended.
- 7. You should also bring with you enclosed <u>Attestation Form</u> duly filled in all respect and <u>bring two (extra) passport size recent photographs duly attested by the same authority who attests your Attestation Form.</u>
- 8. Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission's advertised vide Advertisement No.12/2019 dated 06-08-2019 Item No. III.
- 9. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 26-08-2019. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date).
