

HIMACHAL PRADESH PUBLIC SERVICE COMMISSION
Instructions to Candidates

- 1 That you have been provisionally admitted to the post of Lecturer (Swasthvritta) Class-I (Gazetted) (on Contract basis) in the Department of Ayurveda, H.P. Advertised vide Advertisement No. 12/2019 Dated 06-08-2019 Item No.(V) and now the Personality Test for the said post will be held on 22-01-2020 in the office of the Himachal Pradesh Public Service Commission, Nigam Vihar Shimla-171002.
- 2 That you should ensure your presence in the H.P. Public Service Commission on 22-01-2020 at 08:30AM for verification of documents before appearing in the Personality Test.
- 3 The fact that you have been invited for Personality Test does not confer any right on you for selection against the post.
- 4 Please bring original Degree and Result-cum- Detailed Marks Certificates/ Sheet along with attested copies of the following documents with you:-
 - Matriculation certificate or other equivalent certificate showing your date of birth.
 - The Essential Qualifications:
 - (i) Bachelor Degree in Ayurveda from a recognized University or Council of Indian System of Medicine established by law or from an Ayurvedic College recognized by the Government.
 - (ii) A postgraduate degree in particular branch of speciality from any recognized University established by Law or the degree recognized by CCIM or H.P. Government;

Post Graduate Degree in Swasthavritta from a recognized University established by Law or the degree recognized by CCIM (Central Council of Indian Medicine) or H.P.
 - (iii) Should have studied Sanskrit as one of the subjects in the course of Bachelor Degree in Ayurveda.
5. “No Objection Certificate” from your present employer in case working on regular basis in Government /Semi Government Organization. Without N.O.C. you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce N.O.C
6. Latest Character certificate from a responsible Officer (Gazetted Officer of Government / Semi Government Organization) and **other Character certificate from Head of the Institution last attended.**
7. You should also bring with you enclosed Attestation Form duly filled in all respect and bring two (extra) passport size recent photographs duly attested by the same authority who attests your Attestation Form.
8. Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission’s advertised vide Advertisement No.12/2019 dated 06-08-2019 Item No. (V).
9. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 26-08-2019. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date).
- 10 Your admission to the Personality Test is purely provisional subject to the verification of your eligibility as per rules / instructions.

- 11 Onus of proving that you are eligible for the post is on you only. If the date of notification / declaration of result is not indicated in the certificate / degree / marks list, the date of issue of certificate / degree / marks list shall be deemed as date of acquiring essential qualification.
- 12 Ward/Wives of Ex-Serviceman Certificate issued by a competent authority i.e. SDM/ Tehsildar along with a latest affidavit duly attested by the authority authorized under the Indian Oath Act to the effect that no person in the family has been rehabilitated through employment against the posts reserved for Ex-Servicemen under the Government of Himachal Pradesh.
- 13 If you fail to produce any of the certificates mentioned above, which is necessary to determine your eligibility and/or you are found ineligible vis-à-vis qualifications, you will not be allowed to appear before the Personality Test board and no further time will be allowed to produce any document.
- 14 Besides, your eligibility will be subject to the conditions given in Advertisement No.12/2019 dated 06-08-2019 Item No. (V).
- 15 No T. A. / D.A. will be paid for appearing in this Personality Test However, 30 % discount is allowed by the HRTC in ordinary buses only for attending the Personality Test as per communication received from HRTC and discount will be applicable for only three days i.e. one day before and after the Personality Test for to &fro journey.
