- 1. You have been provisionally admitted on claim basis to appear in the Screening Test for recruitment to the post of Drugs Inspector in the department of Health & Family Welfare H.P. subject to the fulfillment of conditions as laid down in the **Advertisement No. 3/2013 dated 11.10.2013**. Your candidature is liable to be cancelled if you are found to be ineligible for the posts at any stage of the selection process or thereafter.
- 2. As per requirement of advt. No. 3/2013, you are advised to submit attested photocopies of the following documents alongwith a printout of online recruitment application in support of your eligibility as mentioned in the advertisement on the day of Screening Test on **09-03-2014**; failing which your candidature will stand cancelled automatically:
 - i) Matriculation certificate or other equivalent certificate showing your date of birth.
 - ii) Bachelor's Degree and detailed marks certificate as per essential qualifications mentioned in the advertisement.
 - iii) Scheduled Caste/Scheduled Tribe & latest Other Backward Classes certificate on the prescribed form, if you belong to any of these categories. <u>The S.C/S.T/OBC certificate should be based on the lineage of parental family.</u>
 - (v) The candidates belonging to Ex-Servicemen category shall submit discharge certificate & other related documents issued by the competent authority as a proof of being Ex-Serviceman.
 - (vi) Candidates belonging to Physically Disabled categories having not less than 40% disability) should also submit proof.
 - (vi) Any other certificates of your academic qualifications/experience etc. in support of your eligibility for the post(s) as required in the **Advertisement No.3/2013dated 11-10-2013.**
- 3. You should bring your e-admission letter and paste latest passport size photograph duly attested by a Gazetted Officer on the e-admit card. **No candidate will be allowed to appear in the screening test without photograph.**
- 4. <u>Your eligibility in terms of essential qualification(s) and experience etc. shall be reckoned as on the last date of receipt of online recruitment applications i.e. 13.11.2013</u>

The screening test will be of two hours duration of Objective Type Multiple Choice comprising of 100 questions, out of which 80 questions will be covering the syllabus as per essential qualification and 20 questions will be of General knowledge (10 questions on Himachal Pradesh and 10 questions on National/International level General knowledge).
- 6. You should bring with you a blue or black ball pen for the test. Please note that you have to mark the answers with blue/ black ball pen only.
- 7. You are advised to reach the examination Centre on the scheduled date at least 30 minutes before the time mentioned in your e-admission letter. No candidate will be allowed to enter the Examination Hall 10 minutes after the commencement of the Test and no candidate will be allowed to leave the examination Hall till the expiry of allotted time.
- 8. Please mention your category in the answer sheet as already claimed by you in your application. Category once claimed at the time of application will not be allowed to be changed.
- 9. No. TA/DA will be paid for appearing in the Screening Test.
