

HIMACHAL PRADESH PUBLIC SERVICE COMMISSION
INSTRUCTIONS TO CANDIDATES FOR THE POSTS OF MEDICAL OFFICER
(GENERAL WING) ADVERTISED VIDE ADVERTISEMENT NO. 3/2015 dated
01-07-2015.

1. You have been admitted provisionally on claim basis to appear in the Screening Test for the post of Medical Officer (General Wing) in the Deptt. of Health & Family Welfare H.P. , subject to the fulfillment of eligibility conditions as laid down in **Advt. No. 3/2015 dated 01.07.2015** .Your candidature is liable to be cancelled, if you are found ineligible for the post(s) at any stage of the selection process or thereafter.
2. As per requirement of advt. No. 3/2015, you are required to submit attested photocopies of the following documents alongwith a printout of online recruitment application in support of your eligibility as mentioned in the advertisement on the day of Screening Test; on **22.11.2015** failing which your candidature will stand cancelled automatically:-
 - i) Matriculation certificate or other equivalent certificate showing your date of birth.
 - ii) Degree and detail marks sheet of MBBS. The MBBS degree must be recognized by the Medical Council of India. The candidates who have passed MBBS Degree from a foreign University must furnish a proof/ certificate of its recognition by the Medical Council of India along with Pass certificate.
 - iii) Completion of Internship certificate as on **30.07.2015**.
 - iv) Scheduled Caste/Scheduled Tribe/WFF & latest Other Backward Classes certificate on the prescribed form, if you belong to any of these categories. The S.C/S.T/OBC certificate should be based on the lineage of parental family.
 - v) The candidates belonging to Ex-Servicemen category shall submit discharge certificate & other related documents issued by the competent authority as a proof of being Ex-Serviceman.
 - vi) Candidates belonging to physically Disabled categories having not less than 40% disability should also submit proof.
 - vii) Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission's Advertisement No. 3/2015).
3. You should bring your e-admission letter and paste latest passport size photograph duly attested by a Gazetted Officer on the e-admit card. **No candidate will be allowed to appear in the screening test without photograph.**
4. Your eligibility in terms of essential qualification(s) and experience etc. shall be reckoned as on the last date of receipt of online recruitment applications i.e. 30.07.2015.
5. The screening test will be of two hours' duration of objective type multiple choice consisting 100 questions. Out of which 80 questions will be covering the syllabus of MBBS Degree and 10 questions consisting of General Knowledge of H.P. and 10 questions consisting of General Knowledge of National / International level.
6. You are advised to reach the examination Centre on the scheduled date **at least 30 minutes** before the time mentioned in your e-admission letter. No candidate will be allowed to enter the Examination **Hall 10 minutes** after the commencement of the Test and no candidate will be allowed to leave the examination Hall till the full allotted time is over.

7. You are advised to bring with you black/ blue ball pen for the screening test. Please note that you have to encode the answers on OMR answer sheet with blue/black ball pen only.
8. Please mention your category in the OMR answer sheet as already claimed by you in your online recruitment application(s). Category once claimed will not be allowed to be changed.
9. No. TA/DA will be paid for appearing in the Screening Test.
