## INSTRUCTIONS TO CANDIDATES FOR THE SCREENING TEST OF MEDICAL OFFICER (DENTAL) IN THE DEPARTMENT OF HEALTH & FAMILY WELFARE

- 1. You have been admitted provisionally on claim basis to appear in the Screening Test for the post of Medical Officer (Dental) Class-I (Gazetted) (on Contract basis) in the Department of Health & Family Welfare, H.P., subject to the fulfillment of eligibility conditions as laid down in Advt. No. 8/2017 dated 12<sup>th</sup> July, 2017. Your candidature is liable to be cancelled, if you are found ineligible for the post(s) at any stage of the selection process or thereafter.
- 2. As per requirement of advt. No. 8/2017, you are required to submit attested/ self attested photocopies of the following documents along with a printout of online recruitment application in support of your eligibility as mentioned in the advertisement on the day of Screening Test; i.e. 24<sup>th</sup> September, 2017, failing which your candidature will stand cancelled automatically:-
- (i) Print out of Online Recruitment Application (ORA).
- (ii) Matriculation certificate or other equivalent certificate showing your date of birth.
- (iii) Degree and detail marks sheets of BDS. B.D.S. degree must be recognized by the Dental Council of India.
- (iv) Certificate of registration with State Dental Council.
- (v) Scheduled Caste/ Scheduled Tribe/ WFF & latest valid Other Backward Classes certificates on the prescribed form, if you belong to any of these categories and Bonafide Himachali Certificate. The S.C/S.T/OBC certificate should be based on parental basis.
- (vi) The candidates belonging to Ex-Servicemen category will have to submit discharge certificate & other related documents issued by the competent authority as a proof of being Ex-Serviceman.
- (vi) Candidates belonging to Physically Disabled categories (having not less than 40% disability), will have to submit proof thereof.
- (vii) Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission's Advertisement No. 8/2017.
- 3. There will be negative marking for incorrect answer for every question and one fourth (0.25) of the marks assigned to that question, will be deducted as penalty.
- 4. You are required to bring your e-Admit Card and paste a latest passport size photograph duly attested by a Gazetted Officer on the e-admit card. No candidate will be allowed to appear in the screening test without photograph. You are also advised to show any valid Photo ID Card/ proof to concerned invigilator.
- 5. Your eligibility in terms of essential qualification(s) etc. shall be reckoned as on the last date prescribed for submission of online recruitment applications, i.e. 31<sup>st</sup> July, 2017.
- 6. The screening test will be of two hours' duration of objective type multiple choice consisting 100 questions. Out of which 80 questions will be covering the syllabus of B.D.S. Degree and 10 questions consisting of General Knowledge of H.P. and 10 questions consisting of General Knowledge of National / International level.
- 7. You are advised to reach the examination Centre on the scheduled date at least 30 minutes before the time mentioned in your e-admission letter. No candidate will be allowed to enter the Examination Hall 10 minutes after the commencement of the Test and no candidate will be allowed to leave the examination Hall till the full allotted time is over.
- 8. You are advised to bring with you black/ blue ball pen for the screening test. You have to encode the answers on OMR answer sheet with blue/black ball pen only.
- 9. You should mention your category in the OMR answer sheet as already claimed by you in your online recruitment application(s). Category once claimed will not be changed.
- 10. No. TA/DA will be paid for appearing in the Screening Test.

Note: NO ELECTRONIC GADGET/ MOBILE PHONES/ ANY OTHER COMMUNICATION/ ELECTRONIC DEVICES ARE ALLOWED IN THE PREMISES/EXAMINATION HALL, THEREFORE, THE CANDIDATE SHOULD ENSURE THAT THEY ARE NOT IN POSSESSION OF ANY KIND OF SUCH DEVICES BEFORE THEY ENTER THE PREMISES/EXAMINATION HALL.
