Himachal Pradesh Public Service Commission today declared the result of Personality Test held w.e.f. 18-06-2019 & 24-06-2019 for recruitment to 100 posts (i) **B.Sc.** (Forestry) = 72 posts (General = 46, SC of HP = 08, ST of HP = 04, OBC of HP = 08, Gen. Ex-SM of H.P. = 03, SC Ex. SM of HP = 01, ST Ex. SM of HP = 01 & OBC Ex. SM of HP = 01) (ii) Non-B.Sc. (Forestry) = 28 posts (General SC of HP = 03, ST of HP = 03, OBC of HP = 03 & Gen. Ex. SM of HP = 03) of Range Forest Officer, Class-II (Gazetted) on contract basis (in the Department of Forests )H.P. in the pay band of Rs.10,300-34800+4800/-GP on contractual amount of Rs. 15,100/- per month. These posts were advertised vide Advertisement No. 4/2017 dated 23-03-2017, Corrigendum dated 21-06-2017 & subsequent Addendum dated 28-07-2017. In response to this total 15,012 applications were received out of which the candidature of 11,495 candidates (Non – B.Sc. Forestry = 10986 & B.Sc. Forestry = 509) was provisionally admitted whereas the candidature of 3717 candidates was rejected for not remitting the requisite fee. The Screening Test for the posts reserved for Non- B.Sc. category was held on 29-10-2017 in which 4683 candidates appeared and 6303 candidates remained absent. Total 626 candidates were declared qualified in the Screening Test. Out of these 626 candidates only 539 candidates were found eligible and were admitted to the Main Written Examination.

No Screening Test was conducted for the posts reserved for B.Sc. (Forestry) as only 509 candidates had applied for these posts. Out of these 509 candidates only 294 candidates were admitted for Main Written Examination. The Main Written Examination for 833 candidates (Non- B.Sc. Forestry = 539 & B.Sc. Forestry = 294) was held w.e.f. 22-07-2018 to 30-07-2018. Total 579 candidates (Non-B.Sc. Forestry = 399 & B.Sc. Forestry = 180) appeared in the said Examination and 254 candidates (Non- B.Sc. Forestry = 140 & B.Sc. Forestry = 114) candidates remained absent.

The result of Main Written Examination was declared on 02-01-2019 in which 64 candidates (Non- B.Sc. Forestry = 54 & B.Sc. Forestry = 10) were declared qualified for Physical Standard Test held on 18-01-2019 & 19-01-2019. One candidate remained absent and 05 candidates could not qualify the Physical Test.

The result of Main Written Examination (after qualifying the Physical Test) was declared on 29-01-2019 in which total 58 candidates (Non-B.Sc. Forestry = 48 (General = 37, SC = 03, ST = 04, OBC = 04 and 10 candidates of B.Sc. Forestry (General = 08, ST of HP= 01 & OBC of HP = 01) were declared qualified and called for personality test w.e.f. 18-06-2019 to 24-06-2019. The names of the following 51 candidates (B.Sc. Forestry = 09 candidates & Non-B.Sc. Forestry = 42 candidates) are being recommended to the Government (in the Department of Forests):-
