## **Proof of Essential Qualification(s):-**

(ii) Full time CA / ICWA / M.Com. / MBA (Finance) with at least 50 % marks in case of SC/ST / internal ( HPPCL) candidates and 55% marks in case of other categories from a recognized University /Institute.

Note:- Candidates with M.Com./MBA (Finance) should have also passed B. Com. at Graduation level.

- (iii) Ward of Ex-Serviceman Certificate on the form prescribed by the Government and issued by a competent authority along with a latest affidavit duly attested by the authority authorized under the Indian Oath Act to the effect that no person in the family has been rehabilitated through employment against the posts reserved for Ex-Servicemen under the Government of Himachal Pradesh.
- (iv) Certificate of Bonafide of Himachali.
- (v) "No Objection Certificate" from your present employer in case regular employee in Government /Semi Government Organization. Without N.O.C. you will not be allowed to appear before the interview board and no further time will be allowed to produce N.O.C.
- (vi) Latest Character certificate from a responsible Officer (Gazetted Officer of Government /Semi Govt. Organization) and <u>other Character certificate from Head of the Institution last attended.</u>
- 5. You should also bring with you enclosed <u>Attestation Form ( available on the website of the Commission )</u> duly filled in all respect and <u>bring two (extra) passport size recent photographs duly attested by the same authority who attests your Attestation Form.</u>
- 6. Any other certificates of your academic qualifications etc. in support of your eligibility for the post(s) as required in the Commission's <u>Advertisement No. 05/2019 dated 04-05-2019</u> (Item No. II C).

- 7. Your eligibility in terms of Essential Qualification(s) and experience etc. shall be reckoned as on the closing date (last date) for submission of online recruitment applications i.e. 23-05-2019. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date).
- 8 Your admission to the personality test is purely provisional subject to the verification of your eligibility as per rules/instructions.
