Himachal Pradesh Public Service Commission today declared the result of the Himachal Pradesh Judicial Service Competitive (Main) Examination-2023 held from 18<sup>th</sup> September, 2023 to 22<sup>nd</sup> September, 2023. In the Preliminary Examination of aforesaid Examination, total 350 candidates were declared qualified for the Main Written Examination, out of which 314 candidates appeared in all the papers of Main Examination.
